

UHIMSS Advocacy meets with Utah Congressional Representatives from the US Senate and US House to promote health IT awareness




Advocacy Chair and Co-Chair, Michael Adair and Mike Maxwell, along with UHIMSS President, Frank Overfelt (pictured above) met in Washington D.C. with Utah representatives Rob Bishop, Mike Lee and Chris Stewart and legislative staff from other Utah offices to promote and advocate for greater health IT awareness and advancement of critical HIMSS initiatives.

UHIMSS seeks to mobilize its members and seeks to perform multiple levels of outreach to local members of Congress and their staff through a variety of initiatives, providing accurate information about health information technology (HIT) to help make effective pubic policy decisions. UHIMSS believes that the appropriate use of health information technology and management systems can transform healthcare to save lives, improve outcomes of care and reduce costs.

The visit was used to promote greater awareness of key

initiatives including; data exchange standards and interoperability, support for Meaningful Use standards, data privacy and security, and user experience. Our state representatives were accommodating and intent on working collaboratively to advance these initiatives as part of the broader legislative process.

Central Utah Clinic Transitions to Revere Health

As of July 8, 2015, Central Utah Clinic is now Revere Health. Since 1960, the medical group has continued to grow and expand its services to local communities. In the last five years, the reach has grown significantly, and the name no longer represented the broader mission and scope of the organization.

helps communicate the

As part of the transition, most aspects of patient and community communication

will undergo change, including at patient check-in where self-service tablets are currently being tested. The automated tablets enable patients to complete most aspects of registration in the waiting room; insurance verification, patient history, provide feedback of care received and even resolve patient responsibility by accepting credit card payments. So far, the streamlined self-service option has been well received and contributes to higher patient satisfaction.
