HEALTHCARE IT ADVOCACY DAY FEBRUARY 10



The picture to the left shows Frank Overfelt, UHIMSS President-Elect with Representative Dunnigan and Senator Shiozawa, who spoke on "Utah and Medicaid Expansion". Representative Dunnigan, Majority Leader House commented that one of the challenges today is there is no comparison shopping, whatever the cost we pay. There is a wide variation in the cost by different providers. They are in the process of gathering claims data from various payers to look at outcomes and to develop metrics. Senator Shiozawa discussed his proposed plan to enable the State to remain flexible with the option to get out in 3 years if there is a reduction in federal funding. He advocated co-pays, so the individual

has skin in the game. His focus is access to primary care verses ED, for non-emergency care.

We also had the pleasure of hearing from Ken Weizel, Managing Partner San Diego, Deloitte & Touche LLP and Laura Summers, Director of State Intelligence, Leavitt Partners._Ken indicated that 65% of the population are on high deductible, low premium health insurance. Although it was assumed the young population would not sign up, 28% are between the ages of 18-34 and 48% are older than age 45, with 120,000 people signed up in Utah for the federal health exchange. From a provider perspective, bigger is better to lower infrastructure costs. From the average revenue of \$1 - \$2B for healthcare organizations, \$200 - \$500M is uncompensated care. To manage healthcare costs, we need to focus on chronic conditions with individuals making different choices. Employers believe healthcare costs stem from hospital costs and are shifting costs to the employee. Laura Summers indicated that there are 65M people on Medicaid nationally today, approximately 1 in 5 individuals. The forecast for 2024 is that there will be more lives on Medicaid than Medicare. The population

includes young adults with no children and the older population with chronic conditions that are pre-Medicare and where discretionary spending is limited. Medicaid expansion strategy is to increase care coordination. IT plays a key role from EHR's with encounter data, tracking quality measures and data analytics with predictive modeling of care for the population. The expansion of Medicaid trend for newly eligible individuals is to move them to a private insurance option.

INNOVATION LUNCHEON MARCH 12

INTERMOUNTAIN COMPREHENSIVE CARE CLINIC

Dave Henriksen, Assistant Regional Operations Manager at Intermountain Medical Group did a fantastic job describing Intermountain's experience with their new Comprehensive Care Clinic.

- Focus is on Intermountain's full financial risk patients and top 5% of patients that produce 51% of the cost over the past 2-3 years. One challenge is patients switching insurances.
- Patients have complex multiple chronic conditions that have often been misdiagnosed and or underdiagnosed often due to limited resources primary care environment.
- Communication is the #1 issue, the doctor can't get hold of the patient. Intermountain is experimenting with a pilot project using I Phone and Savvysherpa technology allowing only communication between the doctor and the patient.
- The initial #1 priority is to ensure that patients are getting the right medications and dosage levels.
- Comprehensive Care Clinic supports the primary care environment providing more resources and is like an ambulatory ICU stabilizing the patient. The team meets every morning to review the patients.
- Phase 3 of the project is to provide a Community Care Management by visiting the patient in their home.
- Bottom line is you can only help patients that want help. The increased focus encourages patients to become an active and responsive participant in their healthcare.
- Preliminary results reflect improved patient outcomes while decreasing costs.

GRAVITAS INSTITUTE – INNOVATIVE CARE MODEL FOR COMPREHENSIVE CLINICAL CARE

Jayme Norrie, Chief Strategic Officer and Founder of the Gravitas Institute provided some thought provoking concepts regarding the integration and consideration of brain health in treating any condition. Gravitas is focused on changing the stigma of mental health to a focus on brain health. Through their innovative research focused on brain data in combination with disease, Gravitas is building comprehensive care models to include brain health. Recognizing that this is a new frontier will also entail providing a means of payment for these services.
